In the reference first cited, the Government recognized the Child Care Institution (viz) Varshini Illam Trust, Kancheepuram District as Specialized Adoption Agency under para 24(2) of Guidelines Governing Adoption of Children, 2015 and also under sub-section (1) of section 65 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (Central Act 2 of 2016) and also to grant both in-country and inter-country adoption license for a period of five years from 23.12.2016 to 22.12.2021.

2. In the reference second cited, the Director of Social Defence has recommended and forwarded the application of Varshini Illam Trust, Chennai District for renewing the in-country and inter-county adoption recognition for five years from **23.12.2021 to 22.12.2026** based on the recommendation of the District Collector, Probation Officer Chennai.

3. After careful consideration, the Government accept the proposal of the Director of Social Defence for the renewal of recognition of the institution viz., Varshini Illam Trust, Chennai District to do in-country and inter-country adoption under regulations 23(2) and 23(4) of Adoption Regulations, 2017 for a period of further five years from **23.12.2021 to 22.12.2026**.

4. Accordingly, the recognition certificate, which is valid for the period of further five years from 23.12.2021 permitting Varshini Illam Trust, Chennai District, to handle both in-country and inter-country adoption is enclosed herewith.

5. The recognition certificate will be withdrawn if the performance of the agency and child care are not found satisfactory.

6. The data on in-country and inter-country adoption of children in the prescribed proforma should be submitted to the Government through the Director of Social Defence, Chennai - 10 every quarter of the year.
